

NOTICE OF REGULAR MEETING OF THE

Lexington, Gorman, TX 76454 followed by Board Training. At that meeting, the Board may deliberate or act on any of the subjects listed on the following agenda. The Board may enter closed meeting to seek the advice and counsel of its attorney at any time during the meeting under the authority of Tex. Gov't Code §551.071 regarding any item listed on the agenda of this meeting or in order for the attorney to provide legal assistance or advice to the Board.
